- **Dearth of money:** Funding facilities are not being greatly implemented especially in rural areas. The lack of abundant funding is restricting the education at this level.
- **Training support:** The successful and effective education at any level requires the qualified and trained instructor. And this is the big challenges of our country to be fulfilled. These challenges need to be minimized.
- **Population explosion:** Population explosion is the general challenges of India. It is not only in case of pre primary education but also for all kind of education is influenced by the explosion of population in India which is noted as the burning issues of our country.
- Conservative mentality: Mentality of the peoples is the big signifier for the all kind development of a country or society or for a nation. Until the mentality of the people is being changed, any targeted situation cannot be improved. The conservative mentality in particular is the big obstacle for the scattered and improvement of early childhood education. They do not allow their child to have formal education due to what they remain uncultured and uneducated.

- The institution should be made available and well equipped in this level of education.

- The inequality regarding the sex, social identity, economic, class, caste etc. must be reduced and for this government may take necessary steps to address this issue.
